

# EXPRESS SECURITIES PVT LTD Account Opening

You can open an account with NSPL in 2 ways

1. **Account Opening-** For instant account opening, you would need Aadhar card, PAN card, a cancelled and a webcam. Your Aadhar card must be registered with your current mobile number. Here are steps to online account opening with NSPL-
  1. Go to EXPRESS SECURITIES PVT LTD website click on the banner for '15 Minutes Account Opening'
  2. This will take you to NSPL eKYC portal.
  3. Get started with online account opening by filling Name, Email and Mobile Number.
  4. Upload the digital copies of the required documents.
  5. Verify your identity through Aadhar OTP.

Your account will be opened instantly and you can access all the features in a few minutes.

2. Call their toll free number and talk to the customer support team. Once you have expressed your interest to open a trading with the company, a company representative will get in touch with you to take the process forward.

## Documents needed for account opening

EXPRESS SECURITIES PVT LTD requires following documents to open the trading :

1. Clear photocopy of PAN Card
2. Proof of Identity- Passport, PAN, Voter ID, Driving License etc.
3. Proof of Address- Voter ID, Driving License, Passport, Ration Card, Attested Photocopy of Bank Passbook/Bank Statement
4. Latest Bank Statement with IFSC/MICR Code
5. Cancelled Cheque
6. 2 Passport Size Photographs

Additional documents as proof of income may be required for trading in derivative segments.

## Check Account Opening Status

The online account is opened instantly.

It takes 3-4 days for opening a trading offline provided all your documents are in order. The company's customer support team will contact you in case there are any discrepancies.

You can check the account opening status online at NSPL eKYC website.

You can also call their toll free number or write an email to the customer support.

### **Account Opening PDF Forms**

To open a trading and a Demat account with the NSPL, you need to register yourself online or call/SMS their toll-free numbers to express your interest. A company representative will get in touch with you and will share the Account Opening PDF Form which you need to download, fill, sign and send it to the company address along with required documents.

The account opening PDF forms are available on the download page of EXPRESS SECURITIES PVT LTD website.

If all your documents are in order, the account will be opened in 3-4 working days.

## **EXPRESS SECURITIES PVT LTD Account Closure Form**

You can close the NSPL trading and the Demat account at any time.

### **Steps to close NSPL Account**

Get in touch with NSPL's customer service team by call/email etc. The customer service representative will assist you in closing the account.

In general, the accounts are not closed online. The company will ask you to fill a form and send it with required documents to the address provided in the form. If you have a joint Demat account then all holders have to sign the form.

If there are any balance funds in your account then it will either be transferred to your bank account.

Before initiating account closure, please make sure that-

1. Close all open positions in F&O.
2. All the securities held in your NSPL Demat account are moved to another account.
3. Clear all dues with the company.

It is advisable that you follow up with the customer service, a couple of weeks from completing the account closure formalities, to check the status of your account.

1. 1. How long does it take to open an account with EXPRESS SECURITIES PVT LTD?

It takes 3 to 4 days to open the trading with the company provided all your documents are in order.
